SYNOPSIS

Sister Supporter is a grass-roots campaign, founded by local Ealing residents in November 2015. We are campaigning for the public space outside Marie Stopes clinic, Mattock Lane, to be free from intimidation and harassment, allowing those who wish to exercise their legal right to healthcare to do so without interference and judgement.

We launched a petition to Ealing Council, asking them to consider a Public Spaces Protection Order outside of the clinic. The evidence in this pack has been gathered by supporters, residents and the Marie Stopes clinic. It is just a fraction of what we have collected, but we believe it demonstrates the necessity of a PSPO on Mattock Lane.

PHOTOGRAPHIC EVIDENCE

The gate and blue door seen to the left of the image is the entrance to the clinic, meaning patients have to walk past protestors and their signs to enter.

On the floor under the number '87' you can see medically-inaccurate images of 'foetuses' and their signs read (from I-r) 'thou shalt not kill', 'abortion: one dead, one wounded', 'give your baby a present, a birthday' and 'abortion kills babies'.

This image clearly demonstrates the pro-life presence goes far beyond 'offering alternatives to abortion and financial and moral support', as they claim.



PHOTOGRAPHIC EVIDENCE

18TH FEBRUARY 2017

The tree seen in this image is directly opposite the clinic door, meaning anyone entering or leaving has to see the large prayer vigil.

We have also been told by the clinic that the prayers can be heard from the consulting rooms, which understandably distresses patients.



19[™] MAY 2017

PHOTOGRAPHIC EVIDENCE

The woman in this image is stood two feet from the clinic entrance (to the left of her) and is holding a gruesome image that medical professionals have confirmed is not that of an aborted foetus.

Her proximity to the clinic entrance and the graphic nature of this image is clearly intended to cause distress.

The woman in the navy coat is seen calling down the path of the clinic, standing on clinic property and continuing to harass a person that has asked to be left alone.

22ND APRIL 2017

PHOTOGRAPHIC EVIDENCE

This model of a plastic foetus was given to a resident by a man standing at the clinic gates, who mistakenly believed she was a patient at the clinic.

Models like these are given out to women using the clinic with the intention of upsetting them.

The following transcripts and screenshots are taken from videos recorded outside the Ealing clinic, featuring one of the regular anti-choice protestors, demonstrating the type of harassment women entering the clinic have to face.

TRANSCRIPT

'This is 11 weeks and that's um, 10 weeks ...[plane noise]... the first pill stops the baby's nutrition and the second pill..[inaudible] but the baby's life can still be saved if the mother's only taken one pill and in some cases we've actually found the mother's, baby's life can still be saved even when she's taken 2 pills'

'So I mean the thing is, are you having a scan today? [woman answers yes] Well, we can arrange a scan for you ... no charge [woman inaudible] the thing is, they won't show you the scan, we can show you the scan ... [woman says no]. Are you sure? Have a look at our leaflet inside ... [inaudible] support. Please take a rosary.'

The claims made in this video are entirely inaccurate. Since the protester is not a medical professional, offering this kind of misinformation is dangerous.

Pregnant people are only allowed a set number of scans for the health of both parent and foetus, offering unlicensed scans puts both at risk. Also, clinics always offer to show the scans should the patient wish to see.

This is a log kept by the clinic staff at Marie Stopes, Ealing. This is only a small fraction of the incidents recorded, but it gives a clear picture of the anti-choice behaviours.

RESIDENTS STATEMENTS

As a resident that lives opposite this clinic, their behaviour causes anxiety and distress among those in my household and we purposefully avoid that side of the road as much as possible. The graphic images they place in the street are not pleasant – particularly when children regularly use this route. I have seen them giving children leaflets which I do not believe to be appropriate and I would not like my own children to see this material.

This morning the blond vigil[er] stopped a young couple and harassed them for over 10minutes I called the... clinic but no one was picking up for those 10 minutes!!! The blond vigil[er] made the girl cry and the man pushed her aside and they finally got into the clinic 8:50am, I'm so upset!!!

- Resident D, Name & Address given

I work very near the clinic on the Uxbridge Road, and I also live in the area (Carlton Rd). I used to use Walpole Park a lot I now avoid the area, and either avoid using Walpole Park or walk much further in order to enter the park by a different way. Sometimes I do walk past the vigils and I find them very distressing............. This has greatly affected my enjoyment of the local area, and Walpole Park in particular.

I've lived in Loveday Road in Ealing for 8 years and walk down Mattock Lane and past the clinic a lot, I've seen protesters offer pink and blue rosaries asking women if they are having a boy or a girl, I've seen them praying for 'murdered' babies and asking women to reconsider their decision, as if the decision to end a pregnancy is a decision made without a lot of thought. I've seen them ask women walking into the clinic if their 'baby's' father know they are killing their child.

RESIDENTS STATEMENTS

I've lived in Ealing for around 3 years now, and have lived on Mattock Lane for a year. I think the presence of the "pro life" protesters is incredibly intimidating, especially as a young woman in the area.... The photos they lay on the ground of a foetus during various stages of development is quite frankly a disgrace.

I've had guests to stay at my flat who are actually outraged at the audacity of these protesters.....stand there all day and terrorise vulnerable women.

I avoid the area if I can as they upset me.

- Resident F, Name & Address given

I live at Lammas Park Road, W5 5JD. On Saturday mornings I generally walk through Lammas Park and it always deeply upsets me to see people waiting outside with the sole intent of distressing these young women further. The dolls and pictures they display are clearly intended to cause even further distress, which has to be seen as intent to cause harm...... I find this situation hugely distressing. It is also an indictment on our social mores that we allow this situation to persist.


